



6. FUNDS OF THE TRUST :

- 5) The founder trustees at present of Four trustees shall be subject to clause 7 (2) of this deed as per to co opt additional trustees who have faith conviction in the ideals and objectives of the trust

8. POWER OF THE BOARD OF TRUSTEES

- 6) The board of trust have the power to appoint or to constitute a managing committee or a sub committee to manage the institution run by the trust and to suit the rules and regulation of the trust.

9) OPERATION OF THE FUND

The funds of the trust shall be operated through an account in any schedule or nationalized banks jointly by the president, General secretary and treasurer
